Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## The District gives notice of its decision to grant permit(s) for the following application(s):

BC Racing Properties LLC, 521 S Econ Cir, Oviedo, FL 32765-4314 application #28813-14. The project is located in Seminole County, Section: 33, Township: 21 South, Range: 31 East, and includes 3.14 acres. The Environmental Resource Permit application is for construction and operation of a stormwater management system with stormwater treatment by retention to serve a project known as BC Racing North American Headquarters Warehouse Facility. The receiving waterbody is Little Econlockhatchee River.

ETS Autos Inc., 2612 Sanford Ave, Sanford, FL 32773-5250, application #103933-3. The project is located in Seminole County, Section: 1, Township: 20 South, Range: 30 East, and includes 1.11 acres. The Environmental Resource Permit application is for construction of a commercial building and associated parking lot for a project known as ETS Autos Inc. The receiving waterbody is Lake Monroe.

Sundance Elevation AZCN, LLC, Ste 1230, 121 S Orange Ave, Orlando, FL 32801-3239, application #96019-9. The project is located in Seminole County, Section: 30, Township: 19 South, Range: 30 East, and includes 1.88 acres. The Environmental Resource Permit application is for construction of a commercial development known as Auto Zone and Care Now Lot C-2. The receiving waterbody is M.M. Smith Canal.
