The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Granada Pointe, LLC, Ste 12, 1185 W Granada Blvd, Ormond Beach, FL 32174-3100 application #144672-1. The project is located in Volusia County, Section: 41, Township: 14 South, Range: 32 East, and includes 32.2673 acres. The Environmental Resource Permit application is for the construction of four units and one out-parcel in the city of Ormond Beach. The total project area is 32.54-acres, which will be constructed in two phases (a total which includes the 10-acre CE) on the north (3.029-acre outparcel) and south sides (12.74-acres) of Granada Blvd. (SR 40) with 6.71-acres dedicated to stormwater. The project is known as Granada Pointe. The receiving waterbody is Tomoka River.

John & Susan Dupree, 34a Larkspur Ct, Asheville, NC 28805-1368 application #146436-1. The project is located in Volusia County, Section: 33, Township: 16 South, Range: 30 East, and includes 4.83 acres. The Environmental Resource Permit application is for the construction of a new, 25,000-sq ft Goodwill store with parking lots and driveways. The project is known as Goodwill DeLand. The receiving waterbody is Lake Gertie.

CC Woodhaven, LLC, 2379 Beville Rd, Daytona Beach, FL 32119-8720 application #99970-5. The project is located in Volusia County, Section: 29, Township: 16 South, Range: 33 East, and includes 19.3 acres. The Environmental Resource Permit application is for construction of a 93-unit townhome complex with associated infrastructure. The project is known as Woodhaven PH-1B. The receiving waterbody is Spruce Creek.

Geosam Capital US LP, 424 Luna Bella Ln, New Smyrna, FL 32168-4681, application #109884-7. The project is located in Volusia County, Section: 15, Township: 17 South, Range: 33 East, and includes 126.79 acres. The Environmental Resource Permit application is for construction of a surface water management system to serve a multi-phase single family residential development known as Coastal Woods: Unit A1 and Unit A2. The receiving waterbody is Turnbull Creek.

Festival Properties, Inc., 1215 Gessner Rd, Houston, TX 77055-6013 application #111538-3. The project is located in Volusia County, Section: 37, Township: 15 South, Range: 33 East; Section: 44, Township: 14 South, Range: 32 East, and includes 4.11 acres. The Environmental Resource Permit application is for a five year extension of a permit. This re-development is for a residential condominium project with parking garage and on-site underdrain stormwater system. The project is known as 957 Beach PUD. The receiving waterbody is Halifax River.
