The District gives notice of its decision to grant permit(s) for the following application(s):

COJ Office of Economic Development, 117 W. Duval Street, Suite 275, Jacksonville, FL 32202-3643 application #70452-51. The project is located in Duval County, Sections: 27, 28, 33 and 34, Township: 2 South, Range: 24 East, and includes 71.0 acres. The Environmental Resource Permit application is for the development of a master stormwater management plan for Cecil Commerce Center. The project is known as Cecil Commerce Center Wetland Creation. The receiving waterbody is Rowell Creek and St. Mary's River.

Century 21 Car Wash 103rd Street, LLC, #4, 11150 San Jose Blvd, Jacksonville, FL 32223-7942 application #147192-1. The project is located in Duval County, Section: 12, Township: 3 South, Range: 25 East, and includes 1.28 acres.
