## The District gives notice of its decision to grant permit(s) for the following application(s):

D.R. Horton, Inc., 1430 Culver Dr NE, Palm Bay, FL 32907-1132 application #90079-3. The project is located in Brevard County, Section: 20, Township: 25 South, Range: 36 East, and includes 22.88 acres. The Environmental Resource Permit application is for construction of a 21 acre residential subdivision with an associated stormwater management system. The system is designed to accept stormwater runoff from a future 11 acre commercial development located east of the subdivision. The project is known as Palm Cove. The receiving waterbody is St Johns River.

City of Cocoa, 65 Stone St, Cocoa, FL 32922-7982 application #147831-1. The project is located in Brevard County, Section: 30, Township: 24 South, Range: 36 East, and includes 2.4 acres. The Environmental Resource Permit application is for construction of a dry retention with underdrain stormwater management system to serve a new fire station headquarters building, condenser buildings, apparatus bays, storage area, and a future EOC building with associated paving, parking, and walkways. The project is known as Cocoa Fire Station #1 Headquarters. The receiving waterbody is St Johns River.

The Environmental Resource Permit application is for a five-year permit extension to complete construction of the project known as Edwards Road Extension. The receiving waterbody is Indian River.

The project is located in Brevard County, Section: 20, Township: 28 South, Range: 37 East, and includes 0.99 acres. The Environmental Resource Permit application is for construction of a new business located within an existing master system known as West Melbourne Interchange Center.
