This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

Corley Island Mobile Manor, 138 Kings Blvd, Leesburg, FL 34748-8507 Consumptive Use Permit application #2891-5, received November 06, 2019. By letter modification, the applicant proposes to replace existing well A (Station Id 10525) with a new 6-inch well that will produce from the same hydrostratigraphic unit as the existing well. Upon completion of the new proposed well, well A (Station ID 10525) will be properly plugged and abandoned by a licensed water well contractor. No change in allocation or permit duration is requested. This modification is being requested due to failing capacity of the existing well. The withdrawals used by this proposed project will consist of groundwater from FAS - Upper Floridan Aquifer via 1 active well and 1 proposed well in Lake County, located in Section: 3, Township: 20 South, Range: 24 East, known as Corley Island Mobile Manor.

Florida Governmental Utility Authority, 280 Wekiva Springs Rd Ste 2000, C/O Government Services Group Inc, Longwood, FL 32779-6098 Consumptive Use Permit application #2612-6, received November 15, 2019. The applicant proposes the continued use of 0.0215 million gallons per day (mgd) of groundwater from the Floridan aquifer for public supply type uses to serve a projected population of 203 through 2039. The withdrawals used by this existing project will consist of groundwater from FAS - Upper Floridan Aquifer via 1 active well in Lake County, located in Section: 36, Township: 20 South, Range: 24 East. This project is known as Palms Mobile Home Park (FGUA).

Florida Governmental Utility Authority, 280 Wekiva Springs Rd Ste 2000, c/o Government Services Group Inc, Longwood, FL 32779-6098 Consumptive Use Permit application #2610-6, received November 15, 2019. The applicant proposes the continued use of 0.0134 million gallons per day (mgd) of groundwater from the Floridan aquifer for public supply type uses to serve a projected population of 119 people through 2039. The withdrawals used by this existing project will consist of Groundwater from FAS - Upper Floridan Aquifer via 1 active well in Lake County, located in Section: 2, Township: 20 South, Range: 24 East,. This project is known as Morningview (FGUA).

The District issues two types of Individual consumptive use permits (CUPs) – staff-issued CUPs and Governing Board-issued CUPs. Decisions on Individual CUP application(s) will be made at either a District service center (if staff-issued) or at the District's Governing Board meeting where permit applications that have not been delegated to District staff will be acted upon. The Governing Board normally meets on the second Tuesday of the month.

Objections, comments, questions, or information regarding an application for an Individual CUP must be made in writing and received by the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at [applicationsupport@sjrwmd.com](mailto:applicationsupport@sjrwmd.com) as soon as possible after the notification of the application receipt. The Permit Application Number or the Project Name should be included in the objection. If the District receives a timely objection, the objector will receive written notice of the District's decision (or intended decision) on the permit application.
