## The District gives notice of its decision to grant permit(s) for the following application(s):

Tri-Star Semi Truck and Trailer Service, LLC, 3507 Rio Grande Ave, Jacksonville, FL 32254 application #153421-2. The project is located in Duval County, Section: 55, Township: 2 South, Range: 26 East, and includes 11.26 acres. The Environmental Resource Permit application is for construction of a surface water management system to serve the expansion of an existing semi-truck trailer storage facility known as Tri-Star Trucking. The receiving waterbody is Little Sixmile Creek.

CrossView Church, Inc., 10679 Old St. Augustine Road, Jacksonville, FL 32257 application #39464-2. The project is located in Duval County, Section: 4, Township: 4 South, Range: 27 East, and includes 5.12 acres. The Environmental Resource Permit application is for modification of an existing stormwater management system to accommodate site improvements involving new buildings and parking renovations known as All Souls Episcopal Church Building and Parking Addition. The receiving waterbody is Oldfield Creek..

The project is located in Duval County, Section: 19, Township: 2 South, Range: 26 East, and includes 1.64 acres. The Environmental Resource Permit application is for redevelopment of the outparcel from a tire center into a bank, with additional pavement and stormwater appurtenances known as Wells Fargo outparcel @ Lowe's of West Jacksonville. The receiving waterbody is Big Fishweir Creek.

Continental 495 Fund, LLC, W134N8675 Executive Pkwy, Menomonee Fls, WI 53051-3310 application #18246-57. The project is located in Duval County, Section: 19, Township: 4 South, Range: 28 East. The Environmental Resource Permit application is for development to 76.7% impervious coverage of a 10.0-acre project site designed for 80% impervious in a master system known as Springs at Flagler Center. The receiving waterbody is Julington Creek.
