SUBJECT: Notice of Receipt of Consumptive Use Permit Application(s) In Putnam County

Dear Sir/Madam:

This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

Edgar Minerals Inc, 651 Keuka Rd, Hawthorne, FL 32640-5944, Consumptive Use Permit application #7882-10, received March 18, 2021. The applicant proposes to construct a replacement well (B - Replacement, Station ID: 506305) due to the casing failure of existing well B (Station ID: 13505), and the addition of a new well (E, Station ID: 506304) to provide water to a scale house. Both the replacement well and new well will be constructed into the same hydrostratigraphic unit as existing well B. No change in allocation or expiration date is requested. The withdrawals used by this existing project will consist of Surface Water from Joberta Pit via 2 active pumps; Surface Water from Williams Pit via 1 active pump; Groundwater from FAS - Upper Floridan Aquifer via 4 active wells and 2 proposed wells; Surface Water from Townsend Pit via 2 active pumps; Surface Water from Ditch via 1 active pump; Surface Water from Ditch via 3 active pumps in Putnam County, located in Sections 23, 24, 25, 26, 34, 35 and 36, Township 10 South, Range 23 East; Sections 4, 5, 6, 8 and 9, Township 11 South, Range 24 East; Sections 28, 29, 30, 31, 32 and 33, Township 10 South, Range 24 East; Section 1, Township 11 South, Range 23 East. This project is known as Edgar Mine.

The file(s) containing the permit application(s) are available at <u>www.sjrwmd.com/permitting</u> and then click on "Regulatory Permit Search".

The District issues two types of Individual consumptive use permits (CUPs) – staff-issued CUPs and Governing Board-issued CUPs. Decisions on Individual CUP application(s) will be made at either a District service center (if staff-issued) or at the District's Governing Board meeting where permit applications that have not been delegated to District staff will be acted upon. The Governing Board normally meets on the second Tuesday of the month.

Objections, comments, questions, or information regarding an application for an Individual CUP must be made in writing and received by the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at <u>applicationsupport@sjrwmd.com</u> as soon as possible after the notification of the application receipt. The Permit Application Number or the Project Name should be included in the objection. If the District receives a timely objection, the objector will receive written notice of the District's decision (or intended decision) on the permit application.

A Notice of Decision (or Notice of Intended District Decision) will be provided to persons who timely requested individual notice. A request for individual notice must be received by the Director, Office of Business and Administrative Services, prior to the date the Notice of Decision (or Notice of Intended District Decision) is generated. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing. For more information, call (386) 329-4570.
