The District gives notice of its decision to grant permit(s) for the following application(s):

Pointe Grand Palm Coast LLC, 1031 W Morse Blvd, Ste 240, Winter Park, FL 32789-3715 application #170296-1. The project is located in Flagler County, Section 10, Township 11 South, Range 30 East, and includes 17.85-acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 17.85-acre project known as Pointe Grand Apartments. The receiving waterbody is Hulett Branch.

City of Palm Coast,24 Utility Dr, Palm Coast, FL 32137-7366 application #18518-14. The project is located in Flagler County, Sections 24 and 25, Township 11 South, Range 30 East, and includes 0.48-acres. The Environmental Resource Permit application is for the Minor Modification of Permit No. 18518-12 to include the construction and operation of a 0.48-acre project known as Belle Terre Bridge Pathway Rehabilitation. The receiving waterbody is Walker Canal.

Toll Southeast LP Company, Inc, 40 Everest Ln, Ste 5, St Johns, FL 32259-4145 application #88948-89. The project is located in Flagler County, Section 6, Township 12 South, Range 31 East, and includes 95.8-acres. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 95.8-acre project known as Palm Coast Tennis Pod. The receiving waterbody is Graham Swamp.
