The District gives notice of its decision to grant permit(s) for the following application(s):

Haven at Debary LLC, 100 Dunbar St, Ste 400, Spartanburg, SC 29306-5189 application #186377-1. The project is located in Volusia County, Section 9, Township 19 South, Range 30 East, and includes 14.44acres. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a 14.4 acre project known as Haven at Debary. The receiving waterbody is Mullet Lake.

The project is located in Volusia County, Section 11, Township 15 South, Range 32 East, and includes 2.39-acres. The Environmental Resource Permit application is for Minor Modification of Permit No. 22680-13 for Daytona Business Park - Lot 3 to include the construction and operation of a 2.39-acre project. The receiving waterbody is Tomoka River.
