The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## **The District gives notice of its decision to grant permit(s) for the following application(s):**

City of Belleview, Bob Titterington, 5525 SE 119th St, Belleview, FL 34420-5176 Consumptive Use Permit #3137-6. By modification, the District authorizes the use of two new 16-inch diameter for testing purposes and the continued use of 1.022 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for public supply use through 2036. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 2 active wells and 2 proposed wells in Marion County, located in Section 23, Township 16 South, Range 22 East; Section 1, Township 17 South, Range 22 East; Sections 29 and 31, Township 16 South, Range 23 East. This project is known as City of Belleview.
