Arrowrock IV Apopka 451 LLC, 135 North Meramec Ave, Ste 600, St Louis, MO 63105 application #185614-1. The project is located in Orange County, Section 9, Township 21 South, Range 28 East, and includes 22.178-acres. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a 22.178-acre project known as 451 Commerce Park. The receiving waterbody is Marshall Lake.

Orange County Capital Projects Division, 400 E South St, Orlando, FL 32801-2816 application #188940-1. The project is located in Orange County, Section 3, Township 23 South, Range 31 East, and includes 38.08-acres.
