The District gives notice of its decision to grant permit(s) for the following application(s):

Florida Hospital Ocala, Inc., 14055 Riveredge Dr, Ste 250, Tampa, FL 33637-2141; Marion County Hospital District C/O Advent Health, 14055 Riveredge Dr, Ste 250, Tampa, FL 33637-2141; application #201131-2. The project is located in Marion County, Section 19, Township 15 South, Range 22 East, and includes 3.29 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as AdventHealth Ocala MOB. The receiving waterbody is the Silver River Drain.

SRPG Summerfield, LLC, 4803 George Rd, Tampa, FL 33634-4250, application #93552-9. The project is located in Marion County, Section 30, Township 17 South, Range 23 East, and includes 1.57 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as SWC US Hwy 301 & SE Hwy 42. The receiving waterbody is an Unnamed Wetland.
