Robert Rogozienski, 886 44th Ct, Vero Beach, FL 32966-2805 Consumptive Use Permit #158804-2. The District authorizes the use of 0.003 million gallons per day of groundwater from the Upper Floridan aquifer to irrigate 1.5 acres of landscape and supplement the onsite pond through 2029. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan aquifer via 1 active well in Indian River County, located in Section 9, Township 33 South, Range 39 East. This project is known as Glendale Lakes Subdivision.
