Sutton Properties of Palm Bay II, LLC, 2135 Palm Bay Rd Ne, Palm Bay, FL 32905-2932 application #16029-12. The project is located in Brevard County, Section 22, Township 28 South, Range 37 East. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a 0.39-acre project known as Bottlebrush Box Culvert. The receiving waterbody is Indian River Lagoon.

Krisztina Kemenes, 6240 S Us Highway 1, Grant Vlkria, FL 32949-2115 application #209710-2. The project is located in Brevard County, Section 34, Township 29 South, Range 38 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 3.47 acres project known as Tropical Marine.
