The District gives notice of its decision to grant permit(s) for the following application(s):

Florida Fish and Wildlife Conservation Commission, 1105 SW Williston Rd, Gainesville, FL 32601-9044; Armory Board State of Florida, 82 Marine St, Saint Augustine, FL 32084, application #208641-2. The project is located in Clay County, Section 25, Township 6 South, Range 23 East, and includes 11.61 acres. The Environmental Resource Permit application is for the construction and operation of a Crayfish Barrier System for a project known as Black Creek Crayfish Barrier. The receiving waterbody is South Fork Black Creek.

Lote Group, Po Box 357742, Gainesville, FL 32635-7742 application #209381-1. The project is located in Clay County, Section 37, Township 6 South, Range 26 East, and includes 0.77 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as US 17 Taco Bell. The receiving waterbody is Governors Creek.

City of Green Cove Springs, 321 Walnut St, City Hall - 2nd Floor, Green Cv Spgs, FL 32043-3441, application #215318-1. The project is located in Clay County, Section 38, Township 6 South, Range 26 East, and includes 3.35 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Gustafson Park. The receiving waterbody is the St. Johns River.
