The District gives notice of its decision to grant permit(s) for the following application(s):

Publix Super Markets, Inc, 3300 Publix Corporate Pkwy, Lakeland, FL 33811-3311 Application #210470-1. The project is located in Duval County, Section 25, Township 3 South, Range 27 East, and includes 5.64 acres. The Environmental Resource Permit application is for the construction of a stormwater management system to accommodate a 48,640 SF Building and associated VUA, for a project known as Publix Baymeadows Redevelopment. The receiving waterbody is Julington Creek.

Chets Creek Southpoint LLC, 4420 Hodges Blvd, Jacksonville, FL 32224-5200 Application #212015-2.
