The project is located in Volusia County, Section 37, Township 16 South, Range 33 East, and includes 1.72-acres. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a project known as Port Orange - DB - T5 - OC. The receiving waterbody is the Halifax Canal.
