The District gives notice of its decision to grant permit(s) for the following application(s):

Maricamp Land LLC, 2441 Ne 3rd St, Ste 201, Ocala, FL 34470-8289, application #107804-15. The project is located in Marion County, Section 8, Township 16 South, Range 23 East, and includes 1.69 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Lot 7 at Maricamp Market Center - Phase 2. The receiving waterbody is a land-locked basin.

WMH Properties LLC, 3501 NE 10th St, Ocala, FL 34470-6423, application #218680-1. The project is located in Marion County, Section 14, Township 16 South, Range 22 East, and includes 38.17 acres. The Environmental Resource Permit application is for the construction of a Stormwater Management System with stormwater treatment by for Greenway Estates, a project to be constructed. The receiving waterbody is a land-locked basin.

Madison West Oaks II, LLC, 558 W New England Ave, Ste 230, Winter Park, FL 32789-4240, application #26671-12. The project is located in Marion County, Section 1, Township 15 South, Range 21 East, and includes 4.0 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Madison Oaks West II. The receiving waterbody is a land-locked basin.
