The District gives notice of its decision to grant permit(s) for the following application(s):

Kimley-Horn & Associates, Inc., 1700 SE 17th St, Ocala, FL 34471-4604 application #137178-4. The project is located in Marion County, Section 21, Township 12 South, Range 21 East, and includes 3.48-acres. The Environmental Resource Permit application is for Construction of a Surface Water Management System with stormwater treatment by retention for Heagy Burry Boat Ramp Improvements, a project to be constructed. A Letter of Consent to construct a boat ramp and docks to be known as Heagy Burry Boat Ramp Improvements, for a project known as Heagy Burry Boat Ramp Improvements. The receiving waterbody is Orange Lake.
