The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Meritage Homes, 1400 Centrepark Blvd, Ste 1000, West Palm Bch, FL 33401-7412 Consumptive Use Permit #190702-2. The District continues to authorize the use of 0.01 million gallons a day (mgd) of surface water from the onsite ponds for irrigation of 8.77 acres of landscape and 0.01 mgd of groundwater from the Upper Floridan aquifer for pond augmentation through 2042. The withdrawals used by this project will consist of Surface Water from Onsite Lake via 1 proposed pump; Groundwater from FAS - Upper Floridan Aquifer via 1 active well in Indian River County, located in Section 9, Township 33 South, Range 39 East. This project is known as Hampton Park.
