## **The District gives notice of its decision to grant permit(s) for the following application(s):**

FDOT D2, 1109 S Marion Ave, Lake City, FL 32025-5874 application #210584-3. The project is located in Alachua County, Sections 21 and 28, Township 9 South, Range 21 East, and includes 2.49 acres. The Environmental Resource Permit application is for Use of the General Permit to FDOT, Counties, and Municipalities to conduct bridge maintenance over Hatchet Creek at State Road 26, a project known as Hatchet Creek Bridge No. 260033 to be constructed. The receiving waterbody is Hatchet Creek.
