City of Jacksonville, 214 N Hogan St # 10, Jacksonville, FL 32202-4240; Finger Lake Bldg E, LLC, 3000 Turtle Creek Blvd, Dallas, TX 75219-6268 Application #70452-148. The project is located in Duval County, Section 10, Township 3 South, Range 24 East, and includes 44.65 acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Cecil Commerce Parcel E. The receiving waterbody is Rowell Creek.

City of Jacksonville, 1410 Gator Bowl Blvd, Jacksonville, FL 32202-1310 application #37714-4. The project is located in Duval County, Section 20, Township 3 South, Range 26 East, and includes 1.75-acres. The Environmental Resource Permit application is for Letter Modification of Permit No. 37714-2 for a project to be constructed and operated, for a project known as Ringhaver Park Artificial Turf Field. The receiving waterbody is the Ortega River.
