The District gives notice of its decision to grant permit(s) for the following application(s):

Indian River County Parks Division, 1590 9th St SW, Vero Beach, FL 32962-4311 application #161901-3. The project is located in Indian River County, Sections 18 and 19, Township 31 South, Range 39 East. The Environmental Resource Permit application is for modification of Permit Number IND-061-161901-1 for the construction and operation of a Stormwater Management System for 2.32-acre project known as Sebastian Harbor Preserve. The receiving waterbody is Collier Creek.

Rowstar, LLC, 750 Park of Commerce Dr, Ste 200, Boca Raton, FL 33487-3650; Florida Department of Transportation, D4, 3400 W Commercial Blvd, Ft Lauderdale, FL 33309-3421 application #223426-1. The project is located in Indian River County, Section 3, Township 33 South, Range 36 East, and includes 0.21-acres. The Environmental Resource Permit application is for Construction and operation of a project known as US-FL-5732 R S Fellsmere. The receiving waterbody is Blue Cypress Marsh Conservation Area.

MidFlorida Credit Union, 129 S Kentucky Ave, Ste 800, Lakeland, FL 33801-5072 application #40841-2. The project is located in Indian River County, Section 3, Township 33 South, Range 39 East, and includes 3.76-acres. The Environmental Resource Permit application is for construction of a Stormwater Management System with stormwater treatment by dry retention for MidFlorida - Vero Beach, a project to be constructed. The receiving waterbody is Main Canal.
