## The District gives notice of its decision to grant permit(s) for the following application(s):

Swan CR-44 Leesburg, LLC, 1600 E 8th Ave, Ste A200, Tampa, FL 33605-3765; Patti and Kellie Kauffman and Kennedy, PO Box 895127, Leesburg, FL 34789-5127 application #179794-3. The project is located in Lake County, Section 16, Township 19 South, Range 25 East, and includes 48.93-acres. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a project known as Morningside at Silver Lake, for a project known as Morningside at Silver Lake. The receiving waterbody is Lake Griffin and Landlocked Depression.

EPG Sunstone Holdings, LLC, 111 S Armenia Ave, Ste 201, Tampa, FL 33609-3337 application #206982-3. The project is located in Lake County, Sections 15 and 22, Township 21 South, Range 25 East. The Environmental Resource Permit application is for modification of an existing Stormwater Management System (Permit 206982-2) for a 56.77-acre project known as Brighthill Phase 1B. The receiving waterbody is Adjacent Wetlands.

Trinity Land Company LLC, 605 Commonwealth Ave, Orlando, FL 32803-5223 application #215857-2. The project is located in Lake County, Section 27, Township 20 South, Range 24 East, and includes 135.26-acres. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a project known as Tierra Vista Residential Development. The receiving waterbody is the Palatlakaha River and wetlands.

Bae Scelfo, 15545 Pendio Dr, Bella Collina, FL 34756-3631 application #82832-41. The project is located in Lake County, Section 12, Township 22 South, Range 26 East. The Environmental Resource Permit application is for Use of the General Permit for Certain Piers and Associated Structures for Scelfo Boathouse - Lake Apopka, 15545 Pendio Drive, a 1,566 total square foot dock with 1,486 square feet constructed over wetlands and the Conservation Easement, to be constructed. The receiving waterbody is Lake Apopka.
