The District gives notice of its decision to grant permit(s) for the following application(s):

West St. Johns Investments, LLC, 9375 US 1 South, St. Augustine, FL 32086, application #158557-2. The project is located in St. Johns County, Section 31, Township 6 South, Range 29 East. The Environmental Resource Permit application is for Minor Modification for a five-year extension of Permit No. IND-109-158557-1 for State Road 16 Commercial to include the construction and operation of a 4.95-acre project. The receiving waterbody is Sixmile Creek.

Isles of the World Homeowners Association, Inc, 5455 A1a S, St Augustine, FL 32080-7111; Westminster Pines, Inc, 80 W LUCERNE CIR, Orlando, FL 32801-3779 application #21489-84. The project is located in St. Johns County, Section 38, Township 6 South, Range 28 East, and includes 0.2-acres. The Environmental Resource Permit application is for Minor Modification of Permit No. IND-109-21489-78 for Westminster Saint Augustine - Parcel 13 Residential Development to include the construction and operation of a project. The receiving waterbody is Mill Creek.

The project is located in St. Johns County, Section 1, Township 6 South, Range 27 East; Section 31, Township 5 South, Range 28 East; Section 36, Township 5 South, Range 27 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 38.81-acre project known as Silverleaf Parcel 14A - Residential Lots for a project known as Silverleaf Parcel 14A - Residential Lots. The receiving waterbody is Trout Creek.
