The District gives notice of its decision to grant permit(s) for the following application(s):

Howey in the Hills LTD, 10165 NW 19th St, Miami, FL 33172; Beauclaire Ventures, LLC, 2405 W PRINCETON ST, STE 2, Orlando, FL 32804-4725 application #18971-21. The project is located in Lake County, Section 35, Township 20 South, Range 25 East, and includes 408.64-acres. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a project known as Hillside Grove. The receiving waterbody is Lake Illinois and Landlocked.

SK Hammock Oaks LLC, 105 Ne 1st St, Delray Beach, FL 33444-3807 application #194336-9. The project is located in Lake County, Section 29, Township 18 South, Range 24 East, and includes 92.11acres. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a project known as Highlands at Hammock Oaks Phases 1 and 2. The receiving waterbody is Lake Miona.
