## The District gives notice of its decision to grant permit(s) for the following application(s):

Honey Branch Acres LLC, 1102 A1A N, STE 102, PONTE VEDRA, FL 32082-4098 application #105774-5. The project is located in St. Johns County, Section 12, Township 7 South, Range 27 East, and includes 273.13-acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Honey Branch Farms. The receiving waterbody is Tocoi Creek.

Sterling Ventures LLC, 23 Panther Ln, Ste 7, Ponte Vedra, FL 32081-8812 Application #71367-4. The project is located in St. Johns County, Section 13, Township 5 South, Range 28 East, and includes 5.15acres. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a project known as Sterling Phase II (Spacio Storage). The receiving waterbody is Six Mile Creek.
