The project is located in Baker County, Section 4, Township 3 South, Range 22 East, and includes 2.54-acres. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a project known as Wawa Fuel Station 5475. The receiving waterbody is Turkey Creek.
