The project is located in Clay County, Section 10, Township 6 South, Range 24 East, and includes 0.24-acres. The Environmental Resource Permit application is for a minor modification of Permit No. IND-019-164639-3 for Clay County Regional Park to include the construction and operation of a project. The receiving waterbody is Black Creek.

The project is located in Clay County, Sections 28 and 33, Township 4 South, Range 26 East, and includes 5.0-acres. The Environmental Resource Permit application is for a minor modification of Permit No. IND-019-84762-4 for Church of Eleven22 to include the construction and operation of a project. The receiving waterbody is the St. Johns River.

3353 Southern Oaks Dr, Green Cv Spgs, FL 32043-9602, application #140249-21. The project is located in Clay County, Section 29, Township 5 South, Range 26 East, and includes 0.02-acres. The Environmental Resource Permit application is for the use of the General Permit for Docks, Piers, and Associated Structures, 62-330.427, F.A.C., for the construction of a 930 square foot single-family dock, cumulatively preempting 905 square feet over sovereignty submerged state lands. Authorization to use Sovereign Submerged Lands in the form of a Letter of Consent for a project that consists of the

construction of a single-family dock with one covered boatlift, known as Goacher Dock. The receiving waterbody is Peter's Creek.
