The project is located in Indian River County, Section 26, Township 31 South, Range 39 East, and includes 34.03-acres. The Environmental Resource Permit application is for Modification of permit to allow personal water craft to slip M4. Install (1) aluminum and stainless steel 4500# gear drive cradle personal water craft lift . Includes: remote control with auto-run limit switch; cable keepers; aluminum bunks; extra set of aluminum bunks and brackets; (4) guide pole brackets; (1) 12 x 12 aluminum walkboard; (4) new marine grade lift pilings wrapped with .030 high density polyurethane pile wrap., for a project known as Michael Creek Subdivision - Slip M4.
