The District gives notice of its decision to grant permit(s) for the following application(s):

Creekview GP, LLC, 7807 Baymeadows Rd E, Ste 205, Jacksonville, FL 32256-9666; Creekview Community Development District, 7807 Baymeadows Rd E, Ste 205, Jacksonville, FL 32256-9666; application #160968-16. The project is located in Clay County, Section 15, Township 5 South, Range 25 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 64.64-acre project known as Creekview Trail Area 6 Phase 1. The receiving waterbody is Bradley Creek.

Joanne Diz, 2305 State Road 207, St Augustine, FL 32086-9329 application #212609-4. The project is located in Clay County, Section 27, Township 6 South, Range 23 East. The Environmental Resource Permit application is for a minor modification of Permit No. IND-019-212609-3 for Camp Blanding JTC ORTC to include the construction and operation of a 4.5 acre project. The receiving waterbody is Kingsley Lake.

Clay County Board of County Commissioners, 477 Houston St, Green Cv Spgs, FL 32043-2438 application #208178-5. The project is located in Clay County, Sections 25 and 36, Township 4 South, Range 24 East. The Environmental Resource Permit application is for use of the General Permit for Certain Minor Activities pursuant to 62-330.474, F.A.C. for the construction of an elevated boardwalk to cross a small flow-way associated with an existing cross culvert beneath Old Jennings Road. The receiving waterbody is Grog Branch.
