This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

Pulte Home Company LLC, 4901 Vineland Rd, Suite 500, Orlando, FL 32811-7300 Consumptive Use Permit application #3296-5, received May 06, 2025. The property is no longer in agriculture and is under development as a residential subdivision that will be served by a water utility. Voluntary Rescission of CUP. There will be no withdrawals used by this project in in Orange County, located in Section 13, Township 20 South, Range 27 East. This project is known as Winding Meadows.

The file(s) containing the permit application(s) are available at www.sjrwmd.com/permitting and then click on "Regulatory Permit Search".

The District issues two types of Individual consumptive use permits (CUPs) – staff-issued CUPs and Governing Board-issued CUPs. Decisions on Individual CUP application(s) will be made at either a District service center (if staff-issued) or at the District's Governing Board meeting where permit applications that have not been delegated to District staff will be acted upon. The Governing Board normally meets on the second Tuesday of the month.

Objections, comments, questions, or information regarding an application for an Individual CUP must be made in writing and received by the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at applicationsupport@sjrwmd.com as soon as possible after the notification of the application receipt. The Permit Application Number or the Project Name should be included in the objection. If the District receives a timely objection, the objector will receive written notice of the District's decision (or intended decision) on the permit application.

A Notice of Decision (or Notice of Intended District Decision) will be provided to persons who timely requested individual notice. A request for individual notice must be received by the Director, Office of Business and Administrative Services, prior to the date the Notice of Decision (or Notice of Intended District Decision) is generated. Please note that filing a written objection does not entitle you to a Chapter 120, Florida Statutes, administrative hearing. For more information, call (386) 329-4570.
