The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Town of Lady Lake, 136 Skyline Drive, Lady Lake, FL 32159-4570 Consumptive Use Permit #50049-10. By letter modification, the District authorizes a change in the permit conditions to remove the requirement that Well 1 (Station ID #116) be abandoned within 90 days of completion of Well 5 (Station ID #507583). The District also continues to authorize the use of 1.188 million gallons per day (mgd), annual average of groundwater from the Upper Floridan aquifer for public supply use through 2026. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 5 active wells; Connection Point from Lady Lake, City Of via 1 active connection point in Lake County, located in Sections 17 and 20, Township 18 South, Range 24 East. This project is known as Town of Lady Lake.
