KBM Professional Office Complex, LLC, 2239 Blanding Blvd, Ste A, Middleburg, FL 32068-4926, application #214050-1. The project is located in Clay County, Section 24, Township 5 South, Range 24 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 3.21-acre project known as KBM Builders CR218. The receiving waterbody is Polander Branch.
