The Environmental Resource Permit application is for Minor Modification of Permit No. 4-035-106781-3 to include the construction and operation of a 7.62-acre project known as Andalusia Bay - Lot #9 as per plans received by the District on October 27, 2014, as amended by the plan received by the District on April 9, 2025. The receiving waterbody is Crescent Lake.
