The District gives notice of its decision to grant permit(s) for the following application(s):

DR Horton, Inc., 1430 Culver Dr NE, Palm Bay, FL 32907-1132 application #186581-4. The project is located in Indian River County, Section 10, Township 33 South, Range 38 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for 77.38-acre project known as Venetian Grove Phase 3. The receiving waterbody is IRFWCD Main Relief Canal.

FDOT District 4, 3400 W Commercial Blvd, Ft Lauderdale, FL 33309-3421 application #234553-2. The project is located in Indian River County, Section 28, Township 31 South, Range 39 East. The Environmental Resource Permit application is for Use of the General Permit to Counties, Municipalities, and other Agencies to Conduct Stormwater Retrofit Activities for SR-5/US-1 from N. of 87th St. to S. of Sebastian Blvd. to be constructed. The receiving waterbody is Indian River Lagoon.
