The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Oak Hammock Preserve Community Association, Inc., 2100 SE 17th St, Ste 601, Ocala, FL 34471-4170 application #19707-34. The project is located in Marion County, Section 26, Township 15 South, Range 22 East. The Environmental Resource Permit application is for the construction and operation of a Stormwater Management System for a 0.27-acre project known as Oak Hammock Preserve Amenity Center. The receiving waterbody is a land locked basin.

Marion County Board of County Commissioners, 412 Se 25th Ave, Ocala, FL 34471-2687, application #90342-4. The project is located in Marion County, Section 24, Township 17 South, Range 23 East. The Environmental Resource Permit application is for the construction and operation of a 2.2-acre project known as Timucuan Road Culvert Replacement. Authorization to use Sovereign Submerged Lands in the form of a SSL Dedicated Easement No. 23647 for a culverted causeway in Lake Weir known as Timucuan Road Culvert Replacement. The receiving waterbody is Lake Weir.
