Putnam County District School Board, 200 Reid St, Palatka, FL 32177-3730 application #208561-3. The project is located in Putnam County, Section 15, Township 10 South, Range 26 East, and includes 15.82-acres. The Environmental Resource Permit application is for the construction of a maintenance road for the previously permitted school reconstruction project, in accordance with the plans received by the District on April 3, 2025, for a project known as PCSD Pre K- 6 School A. The receiving waterbody is Devall Branch.
