The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

JEA, 225 N. Pearl Street, Jacksonville, FL 32202-4513 Consumptive Use Permit #88271-28. By letter modification, the District authorizes updated wellfield operational limits and the use of three relocated proposed wells (Station IDs 535311, 535332, and 535334). The relocated proposed wells will be constructed into the same hydrostratigraphic unit as the existing proposed wells. There is no proposed change in overall groundwater allocation or permit duration. The withdrawals used by this project will consist of Groundwater from FAS - Upper & Lower Floridan Aquifer via 3 proposed wells in Nassau County. This project is known as Wildlight.
