The District gives notice of its decision to grant permit(s) for the following application(s):

Johnson Bros Corporation, A Southland Company , 5517 Hansel Ave, Ste A, Orlando, FL 32809-3403 application #113964-42. The project is located in Clay County, Section 38, Township 6 South, Range 26 East; Section 47, Township 6 South, Range 27 East. The Environmental Resource Permit application is for the construction and operation of a temporary mooring area for a 0.08-acre project known as State Road 16 - Shands Bridge Mooring Piles. The receiving waterbody is Saint Johns River.

Andrew Geisel, 4420 US-1, Suite 1, St. Augustine, Florida 32084 application #232392-2. The project is located in Clay County, Section 41, Township 4 South, Range 26 East, and includes 0.33-acres. The Environmental Resource Permit application is for the use of the General Permit for Minor Activities within Existing Rights-of-Way or Easements for Morgan Street and San Robar Culvert Improvements to be constructed as per plans received by the District on May 5, 2025. The receiving waterbody is Johnson Slough.
