St. Lucie Development Corp, 226 Ocean Way, Vero Beach, FL 32963-2627 application #231817-1. The project is located in Indian River County, Section 19, Township 31 South, Range 39 East. The Environmental Resource Permit application is for Construction and operation of a Stormwater Management System for a 21.43-acre project known as Hawks Landing. The receiving waterbody is Saint Sebastian River.
