The staff of the St. Johns River Water Management District has completed their review of the environmental resource permit application(s) described below. Based on this review, the District gives notice of its decision for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

Lake County Schools, 201 W Burleigh Blvd, Tavares, FL 32778-2407 application #41751-3. The project is located in Lake County, Section 14, Township 19 South, Range 24 East. The Environmental Resource Permit application is for modification of Permit #IND-069-41761-2 for Beverly Shores Elementary School to include the construction and operation of a Stormwater Management System for a 12.3-acre project known as Beverly Shores Elementary School Addition. The receiving waterbody is Lake Griffin.

Florida's Turnpike Enterprise, Florida's Turnpike Milepost 263, Building 5315, Ocoee, FL 34761 application #41869-11. The project is located in Lake County, Sections 16, 17, 7 and 8, Township 21 South, Range 25 East. The Environmental Resource Permit application is for construction and operation of a Stormwater Management System for a 189.44 - acre project known as SR 91 Florida Turnpike Widening from OBrien Road to US 27 North (MP 285.8 to MP 289.3). The receiving waterbodies are Dilly Lake, Lake Kess, Little Everglades and Mulehead Lake.

Tuscany Estates at the Lakes Homeowners Assn, 12801 Brunello Cir, Clermont, FL 34711-3641 application #97843-3. The project is located in Lake County, Section 31, Township 22 South, Range 26 East, and includes 0.094-acres. The Environmental Resource Permit application is for construction of a 729-square-foot dock project known as Tuscany HOA Community. The receiving waterbody is Lake Minnehaha.
