The District gives notice of its decision to grant permit(s) for the following application(s):

Orange County Utilities Engineering Division, 9150 Curry Ford Rd, Orlando, FL 32825-7600 ; Orange County Public Utilities Division, 109 E Church St, Ste 300, Orlando, FL 32801-3326 application #20902-7. The project is located in Orange County, Section 7, Township 23 South, Range 31 East. The Environmental Resource Permit application is for a minor modification of Permit No. 20902-1 for Eastern Regional Water Supply Facility (ERWSF) to include the modification of the previously approved mitigation plan within a 2.328-acre portion of the regulatory conservation easement. The receiving waterbody is Little Econlockhatchee River.
