Hill/Gray Seven LLC, 415 S Orlando Avenue, Suite 221, Winter Park, FL 32789 application #22312-5. The project is located in Seminole County, Section 22, Township 21 South, Range 31 East. The Environmental Resource Permit application is for Minor modification of Permit No. 4-117-22312-1 for Albertsons Shopping Center to include the construction of a 0.91-acre project known as Dutch Bros Coffee - FL0905. The receiving waterbody is Lake Jesup.
