This is your notification that the St. Johns River Water Management District (District) has received the Individual Consumptive Use Permit (CUP) application(s) listed below:

City of Deland, 1101 S Amelia Ave, Deland, FL 32724-6815 Consumptive Use Permit application #50116-33, received June 09, 2025. By letter modification, the applicant is proposing deletion of permit conditions #43 and #44 and replacement with an alternative condition with proposed language that would reflect new compliance requirements that rely upon a City prepared water supply plan that aligns with the Districts MFL prevention and recovery strategy. There is no proposed change in allocation or existing expiration date of January 10, 2037. The withdrawals used by this project will consist of Surface Water from Saint Johns River via 3 active pumps; Surface Water from Bent Oaks via 1 active pump; Groundwater from FAS - Upper Floridan Aquifer via 8 proposed wells and 19 active wells; Surface Water from Wiley Nash stormwater pond via 1 active pump in Volusia County, located in located in Section 22, Township 17 South, Range 29 East; Sections 7-10, 16, 21, 23, 27, Township 17 South, Range 30 East; Sections 27, 29, Township 16 South, Range 30 East; Section 37, Township 15 South, Range 30 East; Sections 17, 18, Township 17 South, Range 31 East. This project is known as City of DeLand.

City of Deltona, 2345 Providence Blvd, Deltona, FL 32725-1806 Consumptive Use Permit application #8658-12, received June 10, 2025. By letter modification, the applicant is proposing deletion of permit conditions #38, 40, 41, 42 and 43 and replacement with an alternative condition with proposed language that would reflect new compliance requirements that rely upon a City prepared water supply plan that aligns with the Districts MFL prevention and recovery strategy. There is no proposed change in allocation or existing expiration date of November 12, 2033. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 10 proposed wells and 25 active wells; Surface Water from Lake Monroe via 1 proposed pump; Connection Point from Volusia County via 1 active connection point; and Surface/stormwater from 2 active and 2 proposed Pump Stations in Volusia County, Sections 1, 10, 11, 12, 14, 17, 18, 19, 2, 29, 30, 31, 34, 36 and 9, Township 18 South, Range 31 East; Sections 1 and 6, Township 19 South, Range 31 East; Section 25, Township 18 South, Range 30 East; Section 36, Township 17 South, Range 31 East. This project is known as City of Deltona.

The District issues two types of Individual consumptive use permits (CUPs) – staff-issued CUPs and Governing Board-issued CUPs. Decisions on Individual CUP application(s) will be made at either a District service center (if staff-issued) or at the District's Governing Board meeting where permit applications that have not been delegated to District staff will be acted upon. The Governing Board normally meets on the second Tuesday of the month.

Objections, comments, questions, or information regarding an application for an Individual CUP must be made in writing and received by the Director, Office of Business and Administrative Services, P.O. Box 1429, Palatka, FL 32178-1429, or by e-mail at <u>applicationsupport@sjrwmd.com</u> as soon as possible after the notification of the application receipt. The Permit Application Number or the Project Name should be included in the objection. If the District receives a timely objection, the objector will receive written notice of the District's decision (or intended decision) on the permit application.
