Winter Springs Golf LLC, 1500 Winter Springs Blvd, Winter Springs, FL 32708-3803 Consumptive Use Permit #3834-5. By letter modification, the District updated the permit conditions in accordance with Section 1.2 of the CFWI Supplemental Applicant's Handbook. No changes were made to the existing permitted allocation or permit duration. The withdrawals used by this project will consist of Connection Point from Winter Springs, City Of - Eastern WRF via 1 active connection point; Groundwater from FAS - Upper Floridan Aquifer via 1 active well in Seminole County, located in Sections 37 and 7, Township 21 South, Range 31 East; Section 7, Township 21 South, Range 30 East. This project is known as Tusawilla Country Club.
