Sivance, LLC, PO Box 1466, Gainesville, FL 32627-1466, application #23405-11. The project is located in Alachua County, Section 13, Township 9 South, Range 20 East. The Environmental Resource Permit application is for minor modification of Permit No. 23405-4 for Milliken Laurel Plant Warehouse and Unloading to include the construction and operation of a 1.86-acre project. The receiving waterbody is Little Hatchet Creek.
