The staff of the St. Johns River Water Management District has completed their review of the consumptive use permit application(s) described below. Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

## **The District gives notice of its decision to grant permit(s) for the following application(s):**

First Coast Regional Utilities, Inc., PO Box 238, Lake Butler, FL 32054-0238 Consumptive Use Permit #213110-2. By letter modification, the District authorizes the use of proposed wells Well 1 (Station ID 555534) and Well 2 (Station ID 555535) with revised well specifications. The District continues to authorize the use of 0.96 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for public supply use (household, commercial, water utility, and unaccounted for), 0.196 mgd of surface water from the stormwater management system for supplementation of the reclaimed water system, and 0.047 mgd of groundwater from the intermediate aquifer for emergency backup use only through 2044. The withdrawals used by this project will consist of Groundwater from Intermediate Aquifer or Confining Unit via 8 proposed wells; Surface Water from Stormwater system via 1 proposed pump; Groundwater from FAS - Upper Floridan Aquifer via 2 proposed wells in Duval County, located in Sections 18 and 7, Township 3 South, Range 23 East. This project is known as First Coast Regional Utilities.
