Based on this review, the District gives notice of its decision to grant permit(s) for the application(s) described below. The District is providing you this notice because you are either listed as a County Interested Person or you expressed an interest in one or more of these application(s).

The District gives notice of its decision to grant permit(s) for the following application(s):

A Duda and Sons, Inc., 1200 Duda Trl, Oviedo, FL 32765-4507 Consumptive Use Permit #3796-11. The District authorizes the use of 0.217 million gallons per day (mgd) of groundwater from the Upper Floridan aquifer for the irrigation of 120 acres of sod and 0.010 mgd of groundwater from the Upper Floridan aquifer for the irrigation of 5.0 acres of landscape through 2035. The withdrawals used by this project will consist of Groundwater from FAS - Upper Floridan Aquifer via 15 active wells in Seminole County, located in Sections 16 and 21, Township 21 South, Range 31 East. This project is known as A Duda & Sons Inc.
