The Environmental Resource Permit application is for Use of the General Permit for the construction of an eight-foot-wide sidewalk along the north side of NW 45th Avenue from Black Forest Way to NW 24th Blvd in the City of Gainesville to be constructed. The receiving waterbody is Hogtown Creek.
